

## Sign a Contract Electronically

After contacting your local Bunge representative to enroll in electronic contract signatures in **BungeServices**, follow these steps to sign your contracts electronically. Not all contracts are able to be signed electronically. Amendments cannot be signed electronically. Please contact your local Bunge office for further details. Such contracts and amendments must be signed manually and returned to Bunge.



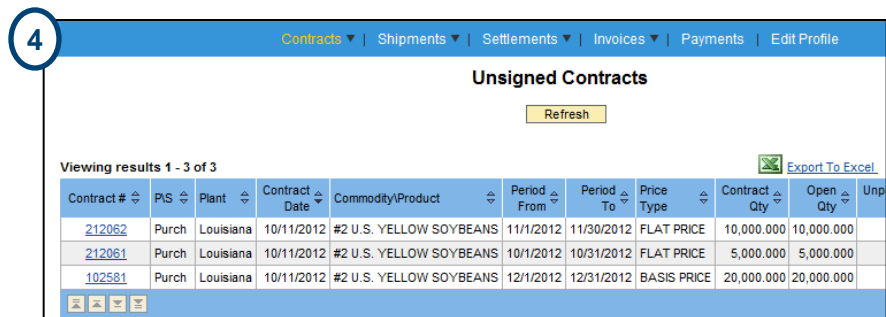
Enter your **Username** and **Password** on the **BungeServices** home page <http://bungeservices.com/agri>.
